For 60 years Open Doors has worked in the world's most oppressive and restrictive countries, strengthening Christians to stand strong in the face of persecution and equipping them to shine Christ's light in these places. In 2015 more than \$6.4 million was contributed towards the worldwide Christian Community Development program. In 2015 Open Doors International served more than 403,000 people (an increase of almost 47,000 people over 2014) through community development projects, such as sponsoring literacy courses, vocational/job training, prison ministry, medical/health care, church restoration, school support, community building aid, safe houses, food supplies, helping widows,

4b (Code:) (Expenses \$ 3,011,800. including grants of \$ 3,011,800.) (Revenue \$) Bible and Literature Distribution

In 2015 over \$3.0 million was contributed towards Bible and Literature Distribution. Open Doors International delivered more than 3.0 million pieces of literature to countries around the world. Of the total of 3.0 million, Middle Eastern and Central Asia countries received the most materials with nearly 2.1 million. The overall distribution total included Bibles, children's Bibles, study Bibles, New Testaments, religious literature, training materials and miscellaneous resources.

In 2015, Open Doors brought about public awareness in several ways:

144,476 people visited our online World Watch List. Over 51,000 churches, church leaders and students were reached through public awareness materials and programs. More than 25,000 people engaged in our advocacy efforts through petitions, letters to representatives, congressional briefings and letters to persecuted believers. A monthly average of 117 radio, print and television pieces featured Open Doors, including USA Today, Fox News and Associated Press.
